And where the Commissioner Prohibition and Excise vide proceedings no. Cr.No.4154/2025/CPE/E3, Dated. 05th February 2026, in exercise of powers conferred under him under Rule 13(8)(c) of the said Rules, has accorded permission to extend the date and time of filing Applications and Drawl of Lots for the 2B Bars where applications are received less than (4) applications as notified in the Gazette notification issued vide reference 4th cited.
